

## **Additional Notification with regard to the KYP New centre registration 2017 process**

Dear Applicant Organization,

This has a reference to your registration as a KYP SDC applicant on Bihar Skill Development Mission (BSDM) portal through the KYP SKILL DEVELOPMENT CENTER REGISTRATION 2017 process. At the onset we would like to thank you for showing interest in being a part of the skilling ecosystem in Bihar. As intimated on BSDM's website the on-boarding process will be in-line to the various points inundated in the "Notice for New Center Registration for KYP" published on BSDM's website.

We have received overwhelming response in KYP SKILL DEVELOPMENT CENTER REGISTRATION 2017 process and on account of this have decided few measures to further strengthen the transparency and fairness in our approach. The measures for your information are:

**POINT 1.** With regard to the following point in our "Notice for New Center Registration for KYP":

"In case even after application of the above mentioned elimination and preference parameters there are multiple applicants vying for the same spot then all such applicants will be called to BSDM office and a lottery will be done in the presence of all to decide the successful applicant/s who would eventually be approved on the portal for that particular block and would be required to move ahead in the registration process"

We would like to inform you that a numeric order will be created through a randomized lottery mechanism for all the eligible applicants at the time of the lottery in presence of all the stakeholders. This numeric order will be used to select the successful applicants as per the number of SDCs required in each block and the rest of the eligible applicants will form our waitlist / panel (in the assigned numeric order) which will be valid till 31st March, 2019. The waitlist / panel in the numeric order will be invited to set-up SDCs in case the initially selected applicants are not able to set-up in the stipulated time or additional SDCs are required in those particular blocks.

For Eg: For Block ABC a total of 2 centres were required:

But a total of 10 applicants had applied and post initial verification 5 of them were found eligible. Thus a numeric order will be created for these 5 eligible applicants through randomized lottery based selection as:

1. A5 Pvt. Ltd
2. A2 Pvt. Ltd
3. A3 Pvt. Ltd
4. A1 Pvt. Ltd
5. A4 Pvt. Ltd

So as the total SDC requirement for block ABC is 2 the first 2 in the numeric order i.e. "A5 Pvt. Ltd" and "A2 Pvt. Ltd" will be the successful applicants whereas the other 3 will be kept in a waitlist / panel in the existing numeric order i.e.

1. A3 Pvt. Ltd
2. A1 Pvt. Ltd

### 3. A4 Pvt. Ltd

**Point 2:** No Applicant shall be allowed to change the following information at any stage during the registration process i.e. prior to final approval:

- Organization Name
- Owner Name
- Registered Mobile Number
- Registered email Id
- Centre District, Block and Address
- Registered Bank Account
