**CORRIGENDUM NOTICE**

**RFP Name:** RFP Name: RFP for Selection of Agency for Establishing, Operating and Maintenance of Migration Counselling Cum Registration Center/s (MCRCs) for Bihar Skill Development Mission (BSDM). vide Ref. No. BSDM/06/2021-2022, notice dated 02.08.2021 published in papers vide PR No. - 0004449 (LRD) 2021-22.

In view of pre-bid meeting dated 12.08.2021, certain modifications/amendments in some of the provisions of above RFP is made as below:

**1. Clause 12 “Preliminary Eligibility Criteria” SN-02- (Page-19) and Clause 13 “Technical Evaluation (Technical Score-ST)” (SN-01- Page-20)**

*The Eligibility Criteria under above points are modified as under:*

The bidder should have Average Annual Turnover of INR 10 Crores in last three financial years i.e. FY 2017-18, 2018-19, and 2019-20.

Accordingly, the SN 1 of Technical Evaluation Criteria is Modified as under:

The bidder should have average annual turnover (AT) of INR 10 Crores in previous three FY 2017-18, 2018-19, and 2019-20.

a. AT = 10 crores

b. 10 crores < AT <= 20 crore

c. AT > 20 crores

**2. The LCS evaluation method for each MCRC is being replaced with QCBS evaluation method. The Clause 14 “Financial Bid Evaluation” is modified to the extent mentioned below:**

**For each MCRC a separate evaluation of Financial Bid shall take place under QCBS method.**

Formula to determine the scores for the Financial Bid for a particular MCRC shall be as follows:

$SF = (FL / F) * 1000$ , Where

- SF is the Financial Score
- FL is the value of lowest Commercial Bid for a particular MCRC
- F is the price quoted in the bid under consideration for that MCRC.

**Combined Evaluation of Technical & Financial Bid for a particular MCRC (QCBS):**

(i) The Total score of the Bidder for a particular MCRC will be determined as under  
Total Score (TS) = (0.8 x ST) + (0.2 x SF)

(ii) The Bid of the Bidder, who obtains the highest TS value, will be rated as the best Bid. In the event of a tie, the bid with the highest technical score (ST) will be rated as the best bid for that particular MCRC. Beyond that, Tendering Authority will decide the matter in its full discretion.

(iii) The Authority will award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the best bid, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily. The Authority shall however not bind itself to accept the best bid or any bid and reserves the right to accept or reject any bid, wholly or in part.

**3. Extension of last date of submission:**

The last date to download/submit/uploading the tender document from the website "https://www.eproc2.bihar.gov.in" is extended from 27.08.2021 (15:00 Hrs.) to **16.09.2021 (15:00 Hrs.)**. **Technical Bid will be opened on or after 16.09.2021 post 16:00 Hrs.**

The other terms and conditions of the RFP document will remain the same. Please refer the RFP document for other details.
