# BS-CFA TRAINING CENTER REGISTRATION 2024 Process – Notification dated 08th August 2024

Notification No. BSDM/SDM-64/2020-

1853

This has a reference to the **BS-CFA Course Training Center Registration 2024 Process** launched by Bihar Skill Development Mission (BSDM) for the pre-identified KYP centers of the identified blocks of the mentioned 20 sub-division headquarter (Annexure I and II). At the onset we would like to invite these KYP centers to be a part of the BS-CFA program of Bihar Skill Development Mission.

BSDM is running this Bihar State Certificate Course in Financial Accounting (BS-CFA) program to create a work force who understand how Goods and Service Tax (GST) levied on the supply of goods and services and to help small and medium enterprises of Bihar for filing GST returns, accounting, and maintenance of records of their Business Enterprise.

BS-CFA is a 120-hour course to impart required skills in youth of Bihar to enhance their employability and self-employability. A special emphasis shall be given to those students who have passed standard 12th examination. The proposed BS-CFA course will be offered to these youths at no cost by establishing new BS-CFA Skill Development Centers at 20 Sub-Divisions in Bihar and to maintain the quality of course delivery the course will be learned through BSDM's eLearning Management System. This eContent will run in a quasi-on-line mode on BSDM Learning Management System (LMS).

This notification is an intimation regarding BS-CFA COURSE TRAINING CENTER REGISTRATION 2024 Process. These KYP Skill Development Centers (SDCs) are encouraged to visit the BSDM website regularly for information published time to time in this respect.

## **BS-CFA SKILL DEVELOPMENT CENTER REGISTRATION 2024 Process Conditions**

- 1. The BS-CFA COURSE TRAINING CENTER REGISTRATION 2024 Process is a restricted registration process opened for pre-selected existing KYP SDCs to take part in the same.
- 2. The BS-CFA center will be empaneled for the Sub-Divisional Headquarter.
- 3. The KYP centers in the blocks mapped to the sub-division will be identified. BSDC centers will not be part of this process on account of limited area availability.
- 4. Only those KYP centers in the blocks mapped to the sub-division which have utilized at least 50% of their capacity in the last six months will be eligible to apply. (The list of such KYP Centers is attached under Annexure II)
- 5. Only those KYP centers in the blocks mapped to the sub-division which have additional space of minimum 100 square feet at their existing KYP center and can thus arrange separate space for the BSCFA center at the same place will be eligible. An additional room of >= 100 sq. ft. that is in addition to the classroom and lab currently being used for the existing KYP SDC must be available. At this moment no center address change for the KYP center will be allowed. Any center that applies for address change post notification of the BS-CFA TRAINING CENTER REGISTRATION PROCESS-2024 will not be included in the lottery despite meeting the other eligibility criteria.

- 6. A physical verification of these KYP centers will be made for the required additional space of minimum 100 square feet at their existing KYP center, may be within 10 days of this notification. The list of successful KYP centers meeting this criteria will be published on BSDM website.
- 7. Also, an intimation will be published on BSDM website to the eligible KYP centers for their presence in a Physical Lottery Process to be conducted at BSDM on a scheduled date which may happen in next 07 days.
- 8. Lottery will be made in presence of the eligible KYP centers of each sub-division, by picking chits.
- 9. Sub-division wise lottery process will be conducted for all the sub-divisions on the same date.
- 10. The KYP centers will have to bring with them a Demand Draft of Rs. 50,000/- (Rs. Fifty Thousand Only) per each KYP code included in the lottery process in favor of "Bihar Skill Development Mission" payable at Patna.
- 11. The KYP centers absent or without the valid Demand Draft will be excluded from the process.
- 12. If any organization has more than one KYP centers in the published list, then it will have to bring separate demand draft for each center else such KYP centers will be excluded from the process.
- 13. The demand draft of unsuccessful KYP centers will be returned immediately on completion of process on the same date. The Demand Draft of selected KYP centers will be kept with BSDM. If the KYP centers fails to establish its BS-CFA center by completing the approval process on BSDM portal within 45 days from the selection date, its demand draft will be forfeited. BSDM will return the demand draft or the amount therein upon final approval of BS-CFA center on BSDM Portal.
- 14. The selected agency will have to meet BS-CFA center set-up guideline as mentioned on BSDM website or as amended time to time.
- 15. CEO, BSDM will have the exclusive discretion and right to modify or relax any of the above provision at any stage either generally or particularly.
- 16. BSDM would like to mention that the selection, post the lottery process, does not guarantee on-boarding or eventual empanelment under BS-CFA program. Final approval / empanelment as BS-CFA center will be subject to the compliance to the BSCFA center registration process on BSDM portal.

#### **Center Setup Norms (post selection)**

- An additional room of >= 100 sq. ft. that is in addition to the classroom and lab currently being used for the existing KYP SDC.
- Minimum 5 additional client systems conforming to the KYP client system specifications to undertake the BS-CFA COURSE training.
- The additional room should have a minimum of 8 feet ceiling (floor to ceiling/ false ceiling as applicable)
- The room should have a concrete roof or else a proper false ceiling in case of an asbestos or any other alternative roofing solution.
- Once selected, the center may choose to use the existing KYP SDC's printer, scanner, power back-up toilets, parking space, reception area, center coordinator, other Non-LF personnel.
- Once selected, the center has to ensure a 256 kbps internet connection for this new setup.
- Once selected, the center needs to deploy an additional LF for undertaking BS-CFA COURSE training who mandatorily meet the eligibility and qualify the BS-CFA onCet exam.



### **BS-CFA Center Registration Process on BSDM Portal:**

- Once selected, the SDCs will have to get itself approved on BSDM portal by abiding to the various BSDM SDC registration guidelines in the stipulated time in order to ensure Final approval / empanelment as BS-CFA COURSE training SDC.
- The SDCs will have to borne and pay various fees like course affiliation fee, processing fee etc. as applicable on BSDM portal in a timely manner. BSDM shall not be liable to refund these fees even if the application for registration gets rejected or the applicant withdraws the application, at any stage after payment.
- If SDC is involved in doing any wrong practice regarding BS-CFA COURSE training program or indulges into franchising / outsourcing / sub-letting of their registered centre in any manner, then their authorization / empanelment will get cancelled / terminated immediately or after the completion of ongoing batch.
- The right to run and operate the skill development center/s as given by BSDM, is a non-transferable allotment and the SDC cannot by its own transfer this right in favour of others.
- This center validity will be till 31-03-2025 only. However, BSDM will have the right to extend the center validity beyond 31-03-2025 also and the SDCs will have to apply for center renewal process as introduced by BSDM time to time.
- BSDM always have the right to terminate the empanelment of Skill Development Centers on closure of the relevant schemes by the Government or for any other reason as per discretion of CEO, BSDM and centers validity will come to an end.

This notice will also be mailed (on their registered Email-Ids) to all the pre identified KYP SDCs from the respective blocks corresponding to the 20 Sub-divisions.
