1. Note on Evaluation Process: Eligibility Criteria

- A) The Applicant Organization (AO) must be registered on or before 31.03.2020.
- B) Average Annual Turnover (AATO) of FY 2019-20, 20-21 & 21-22 must be \geq 100 Lac and positive net worth as on 31.03.2022
- C) Mandatory submission of Audited Financial Statements and CA certificate.
- D) Mandatory submission of Annexure I, II and III (CA Certificates) with UDIN mentioned on all these Annexures.
- E) Mandatory Trained and Placed Figures during last three years i.e., for FY 2020-21, 21-22 & 22-23 is \geq 1000 and 500 candidates respectively.
- F) Valid Placement Letter of Intents (LOI): LOI must contain all of three i.e., Phone Number, E-mail Id and website address of the employer. LOI with deficiency of any one of above is rejected. The total valid LOI placement figure must be \geq 300.
- G) Submission of Notarised Non-Blacklisting Affidavit. Non notarised affidavit is rejected.
- H) Mandatory submission of Annexure VI i.e., Preference of Districts.
- I) Mandatory submission of Tech 1, Tech 2, and Tech 3 Forms.
