The total of Five (5) applicant fulfills all the Eligibility criteria as mentioned in "Eligibility Criteria and Proposal Evaluation" of the RFP and a total of Fifteen (15) applicants were found ineligible out of Twenty (20) application received, due to the non-fulfillment of the prescribed eligibility conditions and/or the non-submission of requisite documents.
