Proceedings of the Technical Evaluation Committee

Submission of proposal were invited through electronic mode onle, and bidders/s were submitting their Bid on E-Procurement platform at www.eproc2.bihar.gov.in.

In response to the above, it is reflected on E-Proc2 portal of Govt of Bihar, that following three organisations have submitted their proposal till the final stipulated time for uploading of Offer/Bid i.e. up to 3.00 PM on 30.06.2025.

1. **M/s SAGAR** (Add: - A-34, Transport Nagar, Sector-69, NOIDA, UP – 201301)
2. **M/s H Kumar's Education Institute** (Add: - 702B, Satkar Complex CG Road, Ahmedabad, Gujrat-380008)
3. **M/s STIFLINK MANAGEMENT (OPC) PVT. LTD.** (Add: - 303, 5TH FLOOR, ADHARSHILA COMPLEX, GANDHI MAIDAN, PATNA, BIHAR-800001)

A meeting of the Technical Evaluation Committee was held on 18th July 2025 wherein the technical document of all the above bidders were evaluated against Pre- Qualification Criteria as specify under the clause 18 “Pre-Qualification” of the RFP

The Technical Evaluation Committee unanimously recommended in the meeting was held on 7th August 2025 for the detailed technical presentation as per clause specified in 19.5 of the RFP for the further Technical Evaluation and scoring to three Qualified Bidders viz. **(i) M/s SAGAR, (ii) M/s H Kumar's Education Institute and (iii) M/s STIFLINK MANAGEMENT (OPC) PVT. LTD.**

Accordingly, the meeting of the Technical Evaluation Committee was held on 13th August 2025 wherein detailed technical presentation and demonstrate as per clause 19 of the Data Sheet of the RFP has been given by all the above Three bidders for further Technical Evaluation and scoring.

Based on the above and detailed technical presentation and demonstrating their credential, Understanding of the Business & Scope of the work of this RFP, Quality and experience of manpower/trainers, Company's relevant experience, understanding of requirements and development

timeline and Assessment of requirements etc., as presented by all the above three Bidders, the Technical Evaluation Committee unanimously marked their technical score as below as per Annexure 1: -

1. M/s SAGAR -80 Marks
2. M/s H Kumar's Education Institute – 95 Marks
3. M/s STIFLINK MANAGEMENT (OPC) PVT. LTD – 65 Marks

Recommendation of the Bid Evaluation Committee

M/s SAGAR and M/s H Kumar's Education Institute successfully met the minimum technical score of 70 as per clause 19 "Technical; Evaluation" of the RFP. Both bidders demonstrated a strong understanding of the project's requirements and presented compelling proposals.

M/s STIFLINK MANAGEMENT (OPC) PVT. LTD. did not achieve the minimum qualifying technical score of 70 as per clause 19 "Technical; Evaluation" of the RFP. As a result, in strict adherence to Clause 20 (II) "Financial Bid Evaluation" of the RFP, this bidder is not eligible to participate in the financial bid opening.

Therefore, Technical Evaluation Committee unanimously recommended M/s SAGAR & M/s H Kumar's Education Institute to opening and of their financial bid for further evaluation under QCBS system as per clause Clause 20 (II) "Financial Bid Evaluation" of the RFP.,
