Proceedings of the Bid Evaluation Committee

In the previous evaluation of the pre-qualification criteria on 18.07.2025, M/s STIFLINK MANAGEMENT (OPC) PVT. LTD. was found to be ineligible because its Net Worth was not stated in the Chartered Accountant's (CA) certificate (UDIN), as required by Annexure-1 of the RFP. This finding was published on the official website and communicated to the applicant via email and phone call.

M/s STIFLINK MANAGEMENT (OPC) PVT. LTD. subsequently submitted additional documents to support its eligibility claim. The Bid Evaluation Committee reconvened to review these supporting documents. The committee thoroughly re-examined all materials, considering only those documents that existed prior to the bid submission deadline. The figures provided were verified against the Unique Document Identification Number (UDIN) portal to ensure they met the pre-qualification criteria outlined in the RFP.

Upon detailed re-evaluation, the committee found that M/s STIFLINK MANAGEMENT (OPC) PVT. LTD. has now satisfactorily fulfilled all the pre-qualification criteria. Consequently, the applicant has been reclassified as eligible to proceed to the next stage of the evaluation process.

Recommendation of the Bid Evaluation Committee

The Bid Evaluation Committee has concluded its review of the supporting documents. As a result, all three applicants have now met the pre-qualification criteria and are recommended to advance to the technical evaluation stage, as per Clause 19 of the RFP.

The eligible applicants are:


1. M/s SAGAR (Add: - A-34, Transport Nagar, Sector-69, NOIDA, UP – 201301)

3. M/s STIFLINK MANAGEMENT (OPC) PVT. LTD. (Add: - 303, 5TH FLOOR, ADHARSHILA COMPLEX, GANDHI MAIDAN, PATNA, BIHAR-800001)

The Bid Evaluation Committee also proposes that the applicants be notified via email and phone call on a date 13th August 2025 at 5.30 PM to schedule their technical presentations. These presentations, as specified in Clause 19.5 of the RFP, will be evaluated based on the following criteria:

- Quality and experience of manpower/trainers
- Company's relevant experience
- Understanding of requirements and development timeline
- Assessment of requirements

The meeting concluded with a vote of thanks. The final proceedings, documenting the eligibility of all three applicants for the technical evaluation stage and the recommendation for their technical presentations, have been prepared and approved by the Technical Committee.
