Subject: Evaluation of Eligibility, Grievance Redressal, and Final Allocation of BSDCs

RFP Name: RFP For Selecting Training Partners to Implement Kaushal Yuva Yojna (KYP) through allotment of 19 Block Skill Development Centers (BSDCs)

RFP No: BSDC/RFP-40-2016(Part-II)-01 Date: 22.01.2025.

Ref: - Proceeding of Evaluation Committee dated 15-05-2025.

In reference to the earlier evaluation of the eligibility criteria for the above-mentioned RFP, a total of fifty-seven (57) applicants were found ineligible out of Two Hundred Eighteen (218) application received, due to the non-fulfillment of the prescribed eligibility conditions and/or the non-submission of requisite documents. The list of these applicants, along with the reasons for their in-eligibility, was published on the official BSDM website and communicated to the concerned applicants via email and through calls made by the BSDM Call Center.

Out of the fifty-seven (57) applicants initially found ineligible, thirty-five (35) applicants submitted grievances and clarifications, along with additional documents, to support their claims of eligibility. In addition, one (1) applicant — GS Techno Innovations Pvt. Ltd. was initially classified as ineligible due to turnover criteria. Upon reexamination of its documents, including verification of the figures available in the UDIN Portal and its financial statements submitted with the proposal, it was confirmed that the applicant satisfies the turnover requirement.

The Bid Evaluation Committee convened to review and assess all grievances and supporting documents submitted by the Thirty-Six (36) applicants comprised of the 35 grievance applicants and GS Techno Innovations Pvt Ltd ensuring that each submission was thoroughly examined against the eligibility criteria outlined in the RFP, and only those documents that were in existence prior to the bid submission deadline were considered.

Upon detailed evaluation, the Committee found that Seven (7) applicants have now fulfilled the eligibility criteria satisfactorily based on their grievances and the documents provided. Consequently, these applicants have been reclassified as eligible for the next stage of the evaluation process.

Recommendation of the bid evaluation committee

The Committee, having concluded its review of the grievances and supporting documents, recommends updating the list of eligible applicants to include the seven (7) newly qualified applicants. As a result, a total of one hundred sixty-eight (168) applicants has met the eligibility criteria. These eligible applicants, as listed in **Annexure 3**, are to be progressed to the next and final stage — the **Allocation Process** — as specified in Section 11(xi) of the RFP.

In line with the RFP provision, the allocation of BSDC centers will be conducted strictly in accordance with the process defined in the RFP, including priority allocation based on the location

of the registered head office (Block-level, District-level, State-level), followed by the tie-breaking mechanism detailed in Section 11.

In addition, **as per Section 6.2 of the RFP**, if any applicant is found to have engaged — directly or indirectly — in any corrupt, fraudulent, coercive, undesirable, or restrictive practice during the Empanelment Process, after the issuance of the Letter of Empanelment, or during the execution of the Agreement, appropriate action will be taken in accordance with the provisions of the RFP.

Accordingly, the Committee has evaluated all eligible applicants and recommends the following applicants for the allocation of BSDCs, as per the RFP guidelines:
