Proceedings of the Bid Evaluation Committee

Submission of Proposals were invited through electronic mode only, and the applicant organization/s (AO) i.e. bidder/s were to submit its/their proposal on e-Procurement platform at www.eproc2.bihar.gov.in.

In response to the above, **four (4)** Organizations had submitted their response to RFP till the final stipulated time for uploading of proposal i.e. up to 03.00 PM on 26th June 2025, which were opened subsequently.

Four (4) organizations fulfilled the eligibility criteria Name as follows: -

1. M/s ICA Edu Skills Pvt. Ltd, (Kolkata, West Bengal)
2. M/s Centre of Technology and Entrepreneurship Development, (Amethi, U.P.)
3. M/s Nidan, (Patna, Bihar)
4. M/s Scope Training & Consulting Pvt Ltd. (Patna, Bihar)

A meeting of the **Technical Evaluation Committee** took place on **July 18, 2025**, to evaluate the technical documents of all bidders against the **Preliminary Eligibility Criteria** as outlined in "Evaluation Bids Phase-I" of the RFP.

Subsequently, in a meeting on **August 12, 2025**, the committee unanimously recommended that all four bidders had qualified for the next stage: the **Technical Evaluation and Technical Presentation**. This was based on the criteria specified under "Technical Evaluation Criteria and score" in the RFP.

On **August 25, 2025**, the committee met again to conduct a comprehensive technical evaluation and review the presentations, as per "Evaluation Bids Phase-II" of the RFP's Data Sheet. During this

session, M/s Nidan did not qualify for the technical evaluation because they failed to give their technical presentation. The committee then unanimously scored the bidders.

1. M/s ICA Edu Skills Pvt. Ltd, (55 Marks)
2. M/s Centre of Technology and Entrepreneurship Development, (90 Marks)
3. M/s Scope Training & Consulting Pvt Ltd. (86 Marks)

Two (2) organizations met the minimum technical score of 60 as per clause Technical Evaluation (Technical Score)-ST) of the RFP. Both bidder's M/s Centre of Technology and Entrepreneurship Development and M/s Scope Training & Consulting Pvt Ltd demonstrated a strong understanding of the project's requirements and presented compelling proposals.

M/s ICA Edu Skills Pvt. Ltd did not achieve the minimum qualifying technical score of 60 as per clause under Technical Evaluation (Technical Score)-ST) of the RFP. As a result, in strict adherence to Clause under "Financial Bid Evaluation" of the RFP, this bidder is not eligible to participate in the financial bid opening.

A meeting for the opening of Financial Bids was held on September 3, 2025. The quoted amounts from each bidder are presented below: -
