treatments to the hair for individual clients. Hairdressing is closely associated with other parts

of the service sector, and with the many products that support it, normally for commercial

purposes.

experienced hairdresser takes on a high level of personal responsibility and autonomy, from

safe working, to achieving exceptional effects for special occasions.

however, these carry with them the need to understand and work with diverse cultures, trends,

and hair types.

MODULE 1 – LADIES HAIRCUT & STYLE

TIME :- 1 Hour 15 mins (5 additional minutes will be given to clean up the station).

MODEL

• Live Model

RATIONAL

 The competitor must cut the model's hair into an everyday commercial salon cut. The hair needs to be blow dried into a fashionable finished style to competitor the haircut.

HAIRCUT

- All cutting tools can be used except a clipper or razor can't be used.
- The commercial cut & style is as per competitors' own choice.

FINISHED STYLE

- The competitor can only use a blow dry to style the hair.
- The finished style should have a neat fashionable finished look to it.
- No pins, clips or accessories of any kind should be found on the finished style.

STYLING PRODUCTS

- The competitor can use any styling products to create the desired style.
- The competitor can't use any thermal equipment such as curling irons, crimping irons, wavers etc. to style the hair.

COLOR

- The competitor need to pre colour all the hair of the model into one colour (Natural Brown).
- Coloured sprays, coloured gels, coloured mousses, coloured markers, crayons, temporary colour etc. can't be used on the finished style.

PENALTY

If the above rules are not followed.

Note: The models need to just wear any simple smart Black outfit. The judges will only be judging the haircut & style not the clothes or jewellery worn by the models.

MODULE 2 – MEN'S FASHION HAIRCUT & STYLE

TIME: 1 Hour 15 mins (5 additional minutes will be given to clean up the station).

MODEL

· Live model.

RATIONAL

The competitor will cut the models hair to reflect a fashionable men's haircut.

COLOUR

• All of the models hair needs to be pre coloured into a (Brown) shade.

 Coloured sprays (including glitters), coloured mousses, coloured gel &coloured markers, crayons etc can't be used.

STYLING PRODUCTS

• The competitor can use all styling products to style the haircut into a fashionable style.

FINISHED STYLE

The haircut can be styled using any styling equipment, blow dryer, curling iron, crimping iron etc.

HAIRCUT

- The competitor can use all haircutting tools to cut the hair.
- The finished hair style can't reflect an Avant Garde design.

PENALTY

If the above rules are not followed.

Note: The model has to wear a simple clean smart black outfit. The judges will only be judging the haircut & style not the clothes worn by the model.

MODULE 3 – LADIES LONG HAIR UP

TIME:- 1 Hour 30 mins (5 additional minutes will be given to clean up the station).

MODEL

Live

RATIONAL

 The competitor needs to create a fashionable long hair up hairstyle worn by an everyday client to a party or event. This is not a Bridal hairstyle.

COLOR

- All model's hair needs to be pre coloured into a global hair colour (natural Brown).
- Coloured sprays (including glitter), coloured mousse, colored gels, markers and crayons etc cannot be used.

STYLING PRODUCTS

• The competitor can use all kinds of styling products to create the finished style.

FINISHED RESULT

- The competitor has a free choice of tools. Can use all the thermal equipment's such as curling iron, wavers, crimping rods etc. to create the final look.
- Ornamentation has to enhance the hairstyle and can't cover more than 25% of the head.
- Hair fillers/stuffing or padding cannot be used.
- Hair nets cannot be used.
- Hair pieces/hair attachments can't be used.
- The hair can't to be cut only the edges of the style can be trimmed with a scissor to give the style a neat look.

PENALTY

If the above rules are not followed.

Note: The model has to wear a simple clean smart black outfit. The judges will only be judging the haircut & style not the clothes worn by the model.

Section - C

C. Marking Scheme

The Assessment is done by awarding points by adopting two methods, Measurement and Judgments

Measurement
 Judgments
 One which is measurable
 Based on Industry expectations

Aspects are criteria's which are judged for assessment

Measurement is used to assess accuracy, precision, and other performance which can be measured in unambiguous way. Mark is awarded in full for a dimension with in tolerance and zero when it is out of tolerance.

Judgment is used to assess the quality of performance, about which there may be small differences of opinion.

The scores from 0 to 3 are awarded for conformity with industry standards (score 1 stands for 1/3 and score 2 for 2/3 of the maximum mark allotted for the criterion).

Example-Judgment Marking

If maximum marks for Judgment criteria is 1 and if all 3 Experts (Juries) give 3 points to a candidate, the candidate will get 1 mark for that aspect. If 2 Experts give 3 and 1 Expert gives 2 points, then candidate will get (3+3+2)/9*1 = 0.89 marks for that aspect out of 1 mark.

Section - E

E. Instructions for candidates

- 1. All accredited participants, and supporting volunteers will abide by rules and regulations with regards to Health, Safety, and Environment of the Competition venue.
- 2. All participants, technicians and supporting staff will wear the required protective Personnel clothing such as closed shoes, apron, gloves and mask during color service.
- 3. All participants will assume liability for all risks of injury and damage to property, loss of property, which might be associated with or result from participation in the event. The organizers will not be liable for any damage, however in case of Injury the competitor will immediately inform the immediate organizer for medical attention.
- 4. Competitor will wear the specified clothes by Beauty and Wellness Sector Skill Council.
- 5. The model needs to wear just a single black outfit. The judges will judge the haircut/hairstyle not the Outfit or jewellery worn by the models.
- 6. Competitor cannot have any logos of Brands/Organizations or Associations on their kits etc.
- 7. Competitors will only use the Cape/Apron provided by the Beauty and Wellness Sector Skill Council.
- 8. Competitors, Judges, Support Team are not allowed to use any personal photo or video taking devices On the competition floor once the competition is underway.
- 9. If a piece of equipment fails, the time keeper notes the time and this time will be added at the end of That module time.

Section - F

F. Health, Safety, and Environment

- Competitor and model needs to wear closed comfortable shoes. No high heels.
- As soon as the competition starts work with electric equipment's they need they need to keep the manufacturer's instruction in mind.
- If a competitor injures themselves and unable to continue until the required first aid has been given. No additional time is to be added to their competition time.
- No item can be used that will penetrate the client's skin.
